Front-end Criminal Case Innovations: Lessons from the Field

Superior Court of Arizona in Maricopa County (Phoenix)

Fast-acting, front-end felony processing approaches have been instituted and refined in Phoenix by consolidating preliminary hearings, arrangements and pleas in one appearance with startling results in reducing trial court delay. In this jurisdiction of 4 million people, over 40% of all felony cases are disposed within 40 days of arrest through collaboration among prosecutors, defense lawyers and probation. Other improvements include a unique criminal settlement/pretrial conference approach, and a recent move to a master calendar scheduling system for jury trial settings that promotes date certainty.

The growth of specialized business courts over the last two decades in metropolitan areas from three pilot projects in 1993 to over 40 sites in 22 states has been dramatic. Globalization, information technology, new product development, outsourcing, mergers and acquisitions have all driven the demand for dedicated commercial dockets. Businesses are looking for predictability and a set of legal principles on which they can depend with confidence to avoid future legal entanglements. How can metro courts develop these specialized courts and what does the future hold for them?

The New Self-Service Approach: Strategically Moving Work to Users

Trial court leaders will need a broader array of service-delivery strategies as courts face increasing demands and fewer resources. The standard solution, to hire more staff as intermediaries is becoming increasingly infeasible. A better strategy is to become a more user-friendly court, relying more on court users to participate in service delivery. One of the largest urban courts in the nation, the Los Angeles Superior Court, has embraced this philosophy and is re-making how they serve their customers. Their approach holds promise for other metro courts in re-engineering services.

iCivics: Public Education about the Courts via the Internet

iCivics Inc. promotes civics education and encourages young people to become active citizens through an array of web-based interactive games and activities for students. It was founded by retired U.S. Supreme Court Justice Sandra Day O'Connor to address the growing problem of failing student grades on civic

examinations. A poignant example of that distressing fact is the recent national finding that only 7 percent of eighth graders can describe the three branches of government.

iCivics programs and activities can mesh nicely with virtually any court public education program for young people. In addition to video games that teach the fundamentals about government to students, lesson plans are also available for teachers concerning the branches of government.

Former Florida Supreme Court Chief Justice Anstead is the iCivics chairperson for his state, and Ms. Pitts heads the Florida Law Related Education Association, a nonprofit organization, established in 1984, to improve justice and expand education for democracy through the development and implementation of law related education programs for Florida youth. They will share their insights about this new way to educate people about their courts.


