• Workshop 6: Substance Use and Mental Health

Substance Use disorders and mental health conditions are complex and chronic conditions that affect brain function and behavior and often co-occur. Yet they are treatable. Trauma is highly prevalent amount court-involved people, and the impact of trauma is a contribution factor to both substance use disorders and mental health conditions. Intervention at the earliest point possible improves outcomes. NCSC recently passed a resolution that combines the recommendations of the National Judicial Opioid Task Force as well as the National Task for to Examine State Courts' Responses to mental Illness. Working groups have been established to focus on priority areas. This Workshop will highlight some of these areas and the innovative work being done in Defection and Diversion.

Clear and accessible communication is fundamental to ensure that everyone can fully participate in the court process. People with disabilities are no exception and have a right to effective communication. Despite good intentions, many courts do not have the knowledge or skills needed to identify barriers to access to their courts, including programs, activities, facilities and to hearings themselves. Effective communication is a civil rights and access to justice issue. All that is written and spoken must be accessible. In this plenary you will learn the principles of effective communication in disability and how to overcome communication barriers. You will also learn effective strategies to improve understanding and communication challenges for those with disabilities.

Workshop 7: Project NORTH in Massachusetts

Project NORTH is a free, confidential, and voluntary court-based program providing access to Recovery Support Navigation for court involved individuals and families impacted by substance use located in the State of Massachusetts. This is a grant based, in court program in 14 of the largest courthouses in MA. Navigation is provided by Navigators who work for local licensed

treatment providers Navigators help court users access treatment, recovery, overdose prevention, and community services. Navigators also help with access to health insurance enrolment, prescribers for addiction treatment and psychiatric medication and long-term care coordination. In this Workshop you will learn about the program including not only the Navigator work but also how to secure transportation and sober housing and the challenges in doing so. Detailed data will be presented that will show, among other data points, that 88.9% of the clients who connected with a Navigator and successfully followed up were successful in connecting to care.
