This session is a review of the LEVEL UP (Learning, Engaging, Visualizing, Evolving, Leading for Unlimited Possibilities) program, created and implemented to strengthen leadership knowledge, skills, and attitudes. While it was created with a focus on leaders preparing for upper and executive leadership roles, it is also applicable to leaders currently in such roles wishing to strengthen their leadership skills. The program moves away from lectures and research papers, although leadership theory is embedded deep into all the activities. The focus of the program is to get into the hard, powerful work of honest reflection for self-awareness and what it means for each participant to become a better leader. This shift means that a dedicated facilitator, protected time, limited finances, and a dedicated group of leader/learners can make this type of program happen.

Workshop 4: Connect with Empathy; Lead with Compassion: Superpowers for Court Leaders

Aspen Auditorium

Gordon Griller, Retired Court Executive Officer, Maricopa County, AZ Hon. Roxanne Bailin, Retired Chief Judge, 20th Judicial District Court in Colorado Empathy and compassion are no longer vague concepts confined to psychologists, therapists, or social workers. They're at the center of the 21st-century, effective leadership in virtually all business and public enterprises, including trial courts. Research, however, suggests many leaders struggle to grasp and display empathy, especially in the workplace, and have even more difficulty responding compassionately with action.

Although different behaviors, empathy and compassion are closely related. Both play important roles in forming and maintaining positive interpersonal relationships at the courthouse as well as in our personal lives. According to numerous studies, two of the most valuable skills for successful leadership are "active" listening (the essence of empathy) followed by thoughtful responding (the key ingredient in compassion). These attributes are foundational to effectively communicating – and, in turn, crucial to building trust. This workshop will give you some practical tips and insights into how you can develop your capabilities to become a more caring, considerate, and, ultimately, influential court leader.

Workshop 5: What is Happening to State Trial Court Civil Filings in State Trial Court

This session will review the findings of a recent study of changes in trial court civil filings in five states over a period of 16 to 41 years. The findings are confounding and perplexing. Civil filings are not inexorably rising. Civil case filing levels in these five state trial courts are at or below the levels of 20 years ago. Per capita filings have dropped more steeply. Filing levels, even in large courts, vary widely within states and across states. The impact of changes in procedural and substantive laws and case management practices are not what might be expected. The findings suggest courts revisit what data is collected about filings and acknowledge that filing levels should become a performance measure of public trust and confidence in the judiciary.

 Workshop 6: Sledgehammers, Mosquitos, and Other Enemies of an Inclusive Courtroom Evergreen II

8:30 AM to 9:45 AM PLENARY 3: Breaking Barriers – Ensuring Effective Communication for Individuals with Disabilities in Courts Rocky Mountain Event Center Moderator: Hon. Paula Carey, Retired Chief Justice of the Massachusetts Trial Court Elizabeth Moran, J.D., Executive Director for Arc of Colorado Megan Rusciano, Staff Attorney for the Center for Public Representation

Effective communication is a civil rights and access to justice issue. It is fundamental to ensuring meaningful engagement in due process and the ability for all individuals to fully participate in every aspect of the judicial process. This can be challenging for individuals who have a broad range of disabilities, particularly those with cognitive disabilities which impact an individual's ability to comprehend or express themselves in written or spoken language. Despite the 1990 passage of the ADA and good intentions since, many courts still do not have the knowledge or skills needed to identify the communication barriers impacting equitable and effective communication access to their court services, programs, and activities. In this plenary session, participants will learn the principles of effective communication along with practical tips and strategies for judges and court personnel to overcome communication barriers and ensure meaningful engagement in due process such that all participants in the court system - judges, court personnel, attorneys, experts, advocates, and other staff - are providing effective communication and access to justice for all.

PLENARY 4: Substance Use and Mental Health/ Project NORTH in Massachusetts

Substance Use disorders and mental health conditions are complex and chronic conditions that affect brain function and behavior and often co-occur. Yet they are treatable. Trauma is highly prevalent amount court-involved people, and the impact of trauma is a contribution factor to both substance use disorders and mental health conditions. Intervention and treatment at the earliest point possible improves outcomes. NCSC recently passed a resolution that combines the recommendations of the National Judicial Opioid Task Force as well as the National Task for to Examine State Courts' Responses to mental Illness. Working groups have been established to focus on priority areas. This Workshop will highlight some of these areas and the innovative work being done in Defection and Diversion. The Workshop will also highlight the new Massachusetts Supreme Judicial Court Standards on Substance Use Disorders & Mental Health. The goals of the Standards are to promote public safety, support access to treatment and recovery services, ensure due process, reduce recidivism, and encourage individual accountability.

The Workshop will also highlight Project NORTH which is a free, confidential, and voluntary court-based program providing access to Recovery Support Navigation for court involved individuals and families impacted by substance use located in the State of Massachusetts. This is a grant based, in court program in 14 of the largest courthouses in MA. Navigation is provided by Navigators who work for local licensed treatment providers. Navigators help court users access treatment, recovery, overdose prevention, and community services. Navigators also help with access to health insurance enrolment, prescribers for addiction treatment and psychiatric medication and long-term care coordination. In this Workshop you will learn about the program including not only the Navigator work but also how to secure transportation and sober housing and the challenges in doing so. Detailed data will be presented that will show, among other data points, that 88.9% of the clients who connected with a Navigator and successfully followed up were successful in connecting to care.

PLENARY 5: Colorado Department of Corrections: an "Insider's Perspective" *Rocky Mountain Event Center Jason Hogan*

One of the most significant decisions we make as trial court judges is the choice to sentence a defendant to the Department of Corrections. It has been my experience that many judges know very little about the day-to-day realities of defendants who are serving the DOC sentences that we impose. Jason Hogan served twenty-three years of a seventy-seven year Department of Corrections sentence before attorneys from the Korey Wise Innocence Project at CU law were able to demonstrate that his conviction was flawed. Since his release in May of 2023, Jason has become an advocate for incarcerated people through his work as a re-entry specialist at Breakthrough, a non-profit organization, and through speaking engagements with stakeholders throughout the criminal justice system.

Jason's story is a personal one about his path to exoneration, but he also has a unique ability to answer questions about the realities of DOC from the perspective of a former inmate. Jason was assigned to several different DOC facilities during his incarceration. He is uniquely qualified to speak about the availability of programming, the realities of prison politics, safety, and all other aspects of life on the inside. Jason is willing to answer questions from judges about everything from the daily life of an inmate to his own perspectives about how prison time can change a person, for both the better and for the worse.
